



EMS AWARDS PROGRAM

Rules for nominations:

1. All nominations must be filled out completely.
2. All nominations must be accompanied with a narrative, explaining why the person you are nominating is deserving of this award.
3. Eligibility criteria:
 - **EMT-I** – Any EMT-I currently working for an approved EMS provider in Riverside County and who exhibits exemplary performance in his/her quality of patient care.
 - **EMT-P** – Any EMT-P currently working for an approved EMS provider in Riverside County and who exhibits exemplary performance in his/her quality of patient care.
 - **MICN** – A Riverside County authorized Mobile Intensive Care Nurse currently working as an MICN in Riverside County who exhibits exemplary performance in his/her quality of patient care.
 - **Dispatcher** – A dispatcher who is an active provider of EMS services and who exhibits exemplary performance in his/her quality of dispatching.
 - **Physician** – A physician who is an active provider of EMS services in Riverside County and who exhibits exemplary performance in his/her quality of patient care.
 - **Extraordinary Acts Award** – A member of the public, non-profit agency, caretaker, volunteer, friend, or family member who contributes to emergency medical services through appropriate response and intervention in an individual emergency, or by dedication to the improvement of EMS services in the community. Also includes any of the above named categories who have performed an extraordinary act attempting to save a life. “Extraordinary” is defined as substantially beyond the realm of expected behavior.
4. All nominations must be submitted to the EMS Agency no later than 5:00 PM on Monday, May 5, 2008. 5. Awardees will be recognized at a ceremony on June 14, 2008 at 6:15 PM at the Lake Elsinore Storm stadium, prior to the start of the game, in the 1st base picnic tent. Awards will be presented by Bruce Barton, EMS Director. Awardees' names will also be engraved on a perpetual plaque in the EMS Agency office.

The EMS Agency will honor EMS Team Members with the 2008 EMS Week Awards Presentation on June 14, 2008 at 6:15 PM. This presentation will be held at the Lake Elsinore Storm Stadium, in the tent behind the first base.

The following are the award categories and the eligibility criteria:

- **EMT-P** : Any EMT-P currently working for an approved EMS provider in Riverside County and who exhibits exemplary performance in his/her quality of patient care.
- **MICN** : A Riverside County authorized Mobile Intensive Care Nurse currently working as an MICN in Riverside County who exhibits exemplary performance in his/her quality of patient care.
- **Dispatcher** : A dispatcher who is an active provider of EMS services and who exhibits exemplary performance in his/her quality of dispatching.
- **Physician** : A physician who is an active provider of EMS services in Riverside County and who exhibits exemplary performance in his/her quality of patient care.
- **Extraordinary Acts Award** : A member of the public, non-profit agency, caretaker, volunteer, friend, or family member who contributes to emergency medical services through appropriate response and intervention in an individual emergency, or by dedication to the improvement of EMS services in the community. Also includes any of the above named categories who have performed an extraordinary act attempting to save a life. "Extraordinary" is defined as substantially beyond the realm of expected behavior.
